

Contest Rules

1. Eligibility

2. Sponsor

7. Winner Notification

The potential winner will be notified by email. The potential Grand Prize winner (parent/legal guardian if a minor in his/her state of residence) will be required to complete, electronically sign and submit a Declaration of Compliance within five (5) days of the date notice or attempted notice is sent, in order to claim his/her prize.
